#### MBE - What's that?

Once they arrive in Germany, migrants who had to leave their countries for various reasons, often escaping war-torn regions, are faced with essential questions about their future.

Diakonie offers specialised, individual consulting services for migrants to find the answers to these questions.

Our consulting services include:

- Qualified, interculturally competent consultants trained in social education
- Expertise and short distances, relying on existing contacts in various institutions, including specialised experts and lawyers
- Case management for handling complex issues

Furthermore, our consultants contribute to developing integrative structures as well as intercultural openness and inclusion.



#### We offer advice and information on the following topics and questions:

- Everyday life and living together in a community
- Where can I learn the German language? Do I have to pay for the class myself?
- Matters of residence status and family reunion
- How do I find a **flat** and what do I have to keep in mind?
- Health/pregnancy
- When am I allowed to work? Will my degree be recognised and how do I find work?
- Day-care facilities/school/childcare options
- What are my possibilities regarding social security?
   What kind of financial benefits am I entitled to and how do I apply for them?
- Family-related or personal problems
- How do I find sports or cultural offers?
- Additional possibilities available within the community

#### The MBE addresses:

- Adult migrants and their families with a long-term residency status independent of their origin and religion, as well as ethnic German resettlers
- Recently immigrated people, including EU citizens and recognised refugees, if legal and permanent residence is expected, or in the case of exceptional leave to remain
- Participants of integration classes
- Migrants who have already been living in Germany for a longer period with a special need for integration help services
